#### 2023 Summer School Information Grades 7-12

Please register for summer school classes with your guidance counselor before June 30, 2023

Parents can find the bus pick up time and student schedule via the parent portal on July 5. Transportation pick up times can be found in the *User Defined* tab.

Classes begin on Thursday, July 6, 2023

During summer school registration, parents must complete the front of the emergency health information form (blank forms will be provided by the guidance counselors).

Bus pick up time and student schedule will be available via Parent Portal starting July 5. Transportation pick up times can be found in the *User Defined* tab.

Location: Arlington High School - Students arriving via the school bus will enter AHS at east entrance #37. Students that drive will park in the south lot and enter AHS at east entrance #40. Students that are dropped off will disembark near south entrance #42 and walk to east entrance #40.

Students will not be permitted to leave the building between period 1 and period 2.

Students may view their summer school schedule via the *School Tool* Parent Portal after July 5.

Registration for summer school begins on June 21 through June 30, 2023 with guidance counselors.

Registration closes at 2:30 p.m. on June 30, 2023.

Classes will be held Tuesday, July 6 thru Wednesday, August 17.

Any student who does not register before June 30, 2023 will be placed on a waiting list.

Transportation will be provided.

There will be a limit of two (2) courses per student.

All students will be allowed to enter the building at 7:25 a.m. (enter west side of building). Each period is 120 minutes. Upon completion, once students have exited the building, they are not allowed to re-enter.

After 8:00 a.m. and after 10:05 a.m. visitors will have to use the main entrance of the high school.

#### Attendance:

Attendance for 23 class sessions is a high priority and all students must meet the minimum attendance requirement in order to qualify for class credit. There are no excused absences.

**Summer school students cannot be absent for more than two days.** An accumulation of **four tardies (late to class within the first 15 minutes of class equates to one absence)**. A student is marked absent if he/she arrives after the first 15 minutes. **Any student who misses a third class will be dropped from the class and not receive course credit.**

With the exception of water in a clear container, no food or other beverage of any kind is allowed in the school facility.

Report cards will be available via the *School Tool* Parent Portal at the end of each marking period.

Marking period 1: July 6 – July 13

Marking period 2: July 17 – July 27

Marking period 3: July 31–August 17.

#### **Student Conduct:**

The Arlington Central School District expects all students to conduct themselves in a civil manner that shows regard for other students, staff, and other members of the school and general community. Student conduct is a direct reflection of the work of our school faculty and staff members. Therefore, positive behavior demonstrates a positive educational experience. All members of the school community are expected to engage in school-wide systems to promote positive behaviors, supports, and interventions. Each building will inform students and parents of the school rules regarding dress and prohibited student conduct at the beginning of the school year. Students may be subject to disciplinary action, up to and including suspension from school, when they engage in behavior that is: · Disorderly (i.e., running, misusing equipment) · Insubordinate (i.e., failure to comply with reasonable directions) · Violent (i.e., hurting others, possessing a weapon, threatening others) · Endangering the welfare of others (i.e., discrimination, harassment, intimidation, possession of alcohol or drugs) · Dangerous behavior on the school bus · Academic misconduct (i.e., plagiarism, cheating, forging notes) · Students will be required to wear their school photo identification badge. IDs will be worn on a lanyard around the neck or on a clip above

the waist while on campus.\*Please see the Student Handbook, Technology Acceptable Use Agreements, and Code of Conduct for a more complete list of prohibited behavior.

### Dress Code:

The responsibility for student dress and general appearance rests with individual students and parents. However, the Board of Education requires students to attend school in appropriate dress that meets health and safety standards and does not interfere with the learning process. The Board also requires students to wear appropriate protective gear in certain classes and activities, such as family and consumer sciences, home and career skills, technology education, science labs, physical education, sports, and club activities. Teachers and all other district personnel should exemplify and reinforce acceptable student dress and help students develop an understanding of appropriate appearance in the school setting. Examples of standards of dress include but are not limited to the following: 1. Extremely brief garments and see-through garments are not permitted, including garments that expose a student's mid-section. 2. Underwear should be completely covered with outer clothing. Arlington Central School District Code of Conduct 24 3. Footwear must be worn at all times. Footwear that is a safety hazard will not be allowed. 4. Clothing may not include items that are vulgar, obscene, libelous or that denigrate others on account of race, color, religion, creed, national origin, gender, sexual orientation or disability. 5. Clothing may not include messages or depictions of items that promote or cause fear, violence, or are otherwise disruptive of the educational environment. 6. Clothing may not promote and/or endorse gang involvement, the use of alcohol, tobacco (smoking/vaping) or illegal drugs and/or encourage other illegal activities. 7. Clothing that obstructs the identification of a student, including but not limited to hats and hoods, may not be worn in school except in cases of medical or any otherwise approved reason. 8. Clothing worn for religious and/or cultural reasons should be permitted including but not limited to durags, hijabs, turbans, yarmulkes, etc.

With the exception of water in a clear container, no food or other beverage of any kind is allowed in the school facility.

### Academic Integrity:

Every students' work should be his or her own. Students have the responsibility to complete their work themselves and to acknowledge sources of information used in that work. The Code of Conduct contains more information about the rules of academic integrity and the consequences for violating them.

### Driving on Campus:

The posted speed limit at all times is 10 miles per hour. Reckless driving and loud music will not be tolerated.

### Acceptable Use of Cell Phones/Technology:

These zones identify the acceptable use of cell phones/technology for each area.

#### **Green Zone:**

- Cell Phone/technology use permitted for educational and/or recreational purposes

#### **Red Zone:**

- Cell Phones/technology is restricted
- Allowed only with adult permission

#### **"NO" Zone:**

- Cell Phones/technology may not be used at any time, under any circumstance

- For appropriate use only
- For educational use only

**Green Zone:**

- Library
- Cafeterias
- Senior Lounge
- Before and after school
- School Buses
- Outside the building
- Hallways during passing time

**Red Zone:**

- Classrooms
- Computer labs
- Theaters
- House Offices
- Gyms
- Weight Rooms
- ISS/Detention/AIP
- Dance Studio
- Hallways during instruction

**“NO” Zone:**

- Locker rooms
- Bathrooms
- Exam rooms
- During all emergency drills
- During lockdowns
- During shelter-in-place
- During evacuations
- During fire evacuations
