Dr. Lyons introduced Mr. Albert Cousins, Winter Guard Coach. Mr. Cousins spoke about the incredible work that went into the competition. The Winter Guard placed 7<sup>th</sup> in the world, a tremendous accomplishment. He shared a video of their performance.

# <u>Beekman Elementary School Professional Learning Communities Report – Mr. Matthew Latvis</u>

Mr. Latvis thanked his PTA for the refreshments and welcomed everyone to the meeting. His Professional Learning Community Report gave an overview of areas that have been identified for improvement in student learning. He spoke about the school's implementation of PLC processes and identified the next steps. He also stated that they have been analyzing their current RTI system and discussing changes for the 2016-27 school year that will result in closer ties between RTI and PLC. He reviewed the work the PLC teams are currently working on including student writing and ELA instruction, collaboration, and assessing the effectiveness.

# <u>Credit Recovery Program at Arlington High School – Dr. Fanuele, Mrs.</u> Roberto, and Ms. Weiss.

Dr. Fanuele spoke about the Arlington Blended Learning Education Lab. He explained that the students have more control over time, place and pace. It gives students ownership of their learning. Mrs. Roberto and Ms. Weiss spoke about the credit recovery and how it gives students an opportunity to relearn and demonstrate proficiency on material they have missed and allows them to stay on track. They reviewed the classes that are offered and shared what the students think about the ABLE Lab. Future plans were also discussed.
